CERTIFICATE OF WATER RIGHT

This Is to Certify, That

ALFRED AND MILDRED POOLE

of 11263 Fir Grove Lane, Stayton , State of Oregon 97383 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of North Santiam River and Detroit Reservoir constructed under Permit No. R-1625

a tributary of Santiam River for the purpose of irrigation of 30.9 acres and supplemental irrigation of 1.5 acres

under Permit No. 33628 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 29, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.39 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Reservoir SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 7, T. 10 S., R. 5 E., W.M.; Lot 3 (NW $\frac{1}{4}$ SW $\frac{1}{4}$), Section 17, T. 9 S., R. 1 E., W.M.; River - 1330 feet South and 20 feet West from SW Corner, Valentine DLC 46

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to One-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1625; provided further that the right allowed herein shall be limited to the use of stored water only on the lands described as supplemental and is subject to the terms and conditions of Contract No. 14-06-100-6273 or satisfactory replacement between the Bureau of Reclamation and applicant, a copy of which is on file in* and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
