CERTIFICATE OF WATER RIGHT

This Is to Certify, That BENTZ BROS. by BERNARD P. BENTZ

of Route 1, Box 108, Scio, State of Oregon 97374, has
a right to the use of the waters of a spring for Tract 1, Neal Creek for Tract 2

a tributary of Neal Creek (Thomas Creek) for the purpose of
stock (Tract 1) and stock drinking directly from the source and is limited not
to exceed 300 head (Tract 2)

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Linn County, and the said decree entered of record at Salem, in the Order Record of
the WATER RESOURCES DIRECTOR, in Volume 18, at page 15; that the priority of the
right thereby confirmed dates from 1852

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per
second from a spring for stock; and shall be further limited to the provisions
of Finding No. 55 of said Decree.

The point of diversion is located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within W. Bilyeu DLC 39,
Section 9, Township 10 South, Range 1 East, Willamette Meridian, being 600 feet
south and 640 feet west from the NE corner W. Bilyeu DLC 39.


A description of the place of use under the right, and to which such right is appurtenant, is as
follows:

And said right shall be subject to all other conditions and limitations contained in said decree.
The right to the use of the water for the purposes aforesaid is restricted to the lands or place of
use herein described.
