## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** PALLIE E. BRESHEARS

of P. O. Box 555, Sweet Home, State of Oregon 97386, has  
a right to the use of the waters of an unnamed stream

a tributary of South Santiam River for the purpose of  
stock drinking directly from the source and is limited not to exceed 5 head

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for  
Linn County, and the said decree entered of record at Salem, in the Order Record of  
the WATER RESOURCES DIRECTOR, in Volume 18, at page 15; that the priority of the  
right thereby confirmed dates from 1875

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an  
amount actually beneficially used for said purposes, and shall ~~not exceed~~ be further limited  
to the provisions of Finding No. 55 of said Decree.

A description of the place of use under the right, and to which such right is appurtenant, is as


Being within that tract of land described as follows:

Part of the Newton Russell D.L.C. No. 41, T. 13 S., R. 1 E. of the W.M., More particularly described as follows: Beginning at a point which is 14.20 chains East and 42.75 chains South of the Northwest corner of said D.L.C.: thence South 12.50 chains; thence West 0.83 chains; thence South 9.62 chains to the Northeast corner of a tract conveyed to Frank P. Coulter by deed recorded July 24, 1945, in Book 171, page 207, Deed Records; thence West 9.02 chains; thence North 22.12 chains; thence East 9.85 chains to the place of beginning; EXCEPTING therefrom a 1 acre tract in the Northeast corner of the above described property conveyed to Daniel Leonard Tiedemann by deed recorded December 3, 1946, in Book 187, page 189, Deed Records; and EXCEPTING therefrom the following described parcel, to-wit: Beginning at an iron pipe which is 287.10 feet East and 3353.12 feet South of the Northwest corner of the Newton Russell D.L.C. No. 41, in Section 33, T. 13 S., R. 1 E. of the W.M.; thence South 686.0 feet to an iron pipe; thence East 266.0 feet to an iron pipe; thence North 686.0 feet; thence West 266.0 feet to an iron pipe and the place of beginning.

And said right shall be subject to all other conditions and limitations contained in said decree.  
The right to the use of the water for the purposes aforesaid is restricted to the lands or place of  
use herein described.
