CERTIFICATE OF WATER RIGHT

This Is to Certify, That EDGAR EUGENE ELLIS

of 760 First Avenue, Sweet Home, State of Oregon 97386, has a right to the use of the waters of an unnamed stream for Tract 1, two unnamed streams for Tract 2, a spring for Tract 3

a tributary of South Santiam River for the purpose of irrigation of 3.8 acres (Tract 1) and stock drinking directly from the sources and is limited not to exceed 50 head (Tracts 2 and 3)

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Linn County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 18, at page 15; that the priority of the right thereby confirmed dates from 1908

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.048 cubic foot per second from an unnamed stream for irrigation; and shall be further limited to the provisions of Finding No. 55 of said Decree.

The point of diversion is located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Young DLC 42, Section 33, Township 13 South, Range 1 East, Willamette Meridian, being 2050 feet south and 1320 feet east from the NW corner Young DLC 42.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:



Being within that tract of land described as follows:
Beginning 49½ rods West of the North East Corner of George Young Donation Land Claim Notification 7621 and claim No. 42; thence South to the south line of said claim; thence West to the Center of George Young and Clarinda Youngs Donation Land claim No. 42 and Notification 7621; thence north to the North line of said claim; thence east to the place of beginning, in Section 33, T. 13 South, R. 1 East and Section 4, T. 14 South, R. 1 East, W. M., less a strip 82 rods and 2 feet long on the south end said strip containing 15 acres more or less.
The West half of the Donation Land Claim of George Young and Clarinda Young, his wife, and known and described in the Land Office at Oregon City, Oregon, as claim No. 42 in Township Thirteen South of Range One East in Linn County, Oregon, containing 160 acres, more or less.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
