CERTIFICATE OF WATER RIGHT

of Star Route 1, Box 124, Lebanon , State of Oregon 97355 , has a right to the use of the waters of a spring for Tract 1 and an unnamed stream for Tract 2

a tributary of South Santiam River for the purpose of stock drinking directly from the sources and is limited not to exceed 20 head

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Linn County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 18, at page 15; that the priority of the right thereby confirmed dates from 1905

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not-exceed be further limited to the provisions of Finding No. 55 of said Degree.

Being within that tract of land described as follows: Beginning at a 3/4" iron pipe which bears South 34° 07' East 31.577 chains from the West & corner of Section 18, Township 12 South, Range 1 West of the W.M. in Linn County, Oregon; thence North 1,170 ft.; thence West 17.725 chains to the west line of said Section 18; thence North 555 ft. to the west $\frac{1}{4}$ corner of Section 18; thence North 52 rods to the southwest corner of that land conveyed to grantee by deed recorded on page 620 of volume 201 of Linn County Deed records; thence East along the south line of said land 86 rods; thence south 52 rods to the northwest corner of the NE4 of the SW4: thence East 2.5 chains; thence south parallel with west line of the NE4 of the SW4 26.143 chains to a point East of the place of beginning; thence West 25.1 rods more or less to the place of beginning and containing 59.3 acres, more or less, subject to the rights of others to use a certain power line road upon the above described property; and also a perpetual non-exclusive right-of-way and easement for the use of the following described roadway: a 50 ft. wide permanent road easement described in deed recorded on page 849 of book 316 of Linn County Deed Records.
