under Permit No. 28944 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dutes from

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.06 cubic foot per second, if available at the original point of diversion; SW4 NE4, Section 20, T. 13 S., R. 29 E., W.M.; 2750 feet North and 2480 feet West from SE Corner, Section 20

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 NW4, Section 20, T. 13 S., R. 29 E., W.M.; 380 feet North and 1300 feet East from W4 Corner, Section 20

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to use of water is limited to the period when the flow of the John Day River is more than 30 c.f.s. at USGS Gage No. 14-0465 and more than 20 c.f.s. at USGS Gage No. 14-0480

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.85 acre SW4 NW4 1.65 acres NW4 SW4 Section 20 T. 13 S., R. 29 E., W.M.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered on June 29, 1979, and together with certificate of water right recorded at page 48348, Volume 41, State Record of Water Right Certificates, supersedes certificate of water right recorded at page 47277, Volume 40, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
