that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.38 cubic feet per seond, if available at the original point of appropriation; NE_4 SE_4 , Section 6, T. 26 S., R. 34 E., W.M.; $20\frac{1}{2}$ chains East and $\frac{1}{4}$ chain South from Center, Section 6

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE4 NE4, Section 6, T. 26 S., R. 34 E., W.M.; 2510 feet South and 1220 feet West from NE Corner, Section 6

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year
