that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.19 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the McCoy Reservoir – NE $_4$ SW $_4$, Section 30, Simms Reservoir – NW $_4$ SE $_4$, Section 31, T. 40 S., R. 13 E., W.M., Mill Creek – SE $_4$ NE $_4$, Section 24, T. 41 S., R. 12 E., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
