CERTIFICATE OF WATER RIGHT

This Is to Certify, That

WILLIAM BUTLER

of Juntura a right to the use of the waters of Bendier Creek and Warm Springs , State of Oregon 97911

, has

a tributary of Malheur River for the purpose of irrigation of 2.9 acres and supplemental irrigation of 4.4 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Malheur County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 8, at page 228; that the priority of the right thereby confirmed dates from January, 1886

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1½ acre feet per acre in any 30 day period prior to June 1st, 1 acre foot per acre in any 30 day period after June 1st, of each year, or 3 acre feet per acre during any season, diverted at a rate not to exceed one-twentieth of a cubic foot per second per acre, if available at the original points of diversion; Bendier Creek and* The point of diversion is located in the SW½ NE½, SE½ SW½, Section 36, T. 18 S., R. 37 E., W.M.; Bendier Creek (Bendier and Warm Springs Ditch), Warm Springs Creek -80 feet North and 300 feet West from S½ Corner, Section 36
