of Route 3, Box 92, Silverton , State of Oregon 97381 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two streams, and reservoirs constructed under Permit No. R-3214,

a tributary of Beaver Creek irrigation of 66.1 acres

for the purpose of

under Permit No. 28624 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 18, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.83 cubic foot per second; being 0.02 c.f.s. from East Stream and 0.81 c.f.s. from West Stream,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 SW4, SW4, SW4, both as projected within Willard DLC, Section 15, T. 7 S., R. 1 W., W.M.; 1090 feet South and 230 feet West; 1490 feet South and 420 feet West, both from NW Corner, Shrum DLC.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoirs constructed under Permit No. R-3214,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
