CERTIFICATE OF WATER RIGHT

This Is to Certify, That G. FRED AND BARBARA J. COX

of PO BCL 932, Bandon, State of Oregon 97411, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Johnson Creek, Crooked Creek and six reservoirs constructed under Permit No. R-5461

a tributary of Pacific Ocean for the purpose of frost control, cranberry flood harvesting for 20.37 acres and irrigation of 14.51 acres

under Permit No. 34284 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 13, 1969

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.10 cubic feet per second, being 1.6 c.f.s. from Johnson Creek and reservoirs and 1.5 c.f.s. from Crooked Creek and reservoirs and being 1.6 c.f.s. for frost control from Johnson Creek, 0.55 c.f.s. for harvesting and 0.27 c.f.s. for *

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 5, SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 8, T. 29 S., R. 14 W., W.M.; Johnson Creek - 2820 feet North and 1570 feet West; Reservoir No. 6 - 280 feet North and 1430 feet West; Reservoir No. 7 - 830 feet North and 1480 feet West; all from the Center of Section 8; NW $\frac{1}{4}$ SE $\frac{1}{4}$, NE $\frac{1}{4}$ SW $\frac{1}{4}$, SE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 8, T. 29 S., R. 14 W., W.M., Crooked Creek - Reservoir No. 1 - 250 feet**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to one-eightieth of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.



**South and 40 feet East; Reservoir No. 2 - 350 feet South and 370 feet West; Reservoir No. 3 - 650 feet North and 110 feet West; Reservoir No. 5 - 440 feet North and 670 feet West; all from the Center of Section 8

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described., and is subject to the existing minimum flow policies established by the Water Policy Review Board.
