that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second, being 0.01 c.f.s. for domestic and 0.01 c.f.s. for stock when available with any deficiency in the available supply from Spring No. 1 to be made up by appropriation from Spring No. 2 provided that the total* or its equivolent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $_4$ SE $_4$, NE $_4$ SE $_4$, Section 34, T. 27 S., R. 5 W., W.M.; Spring No. 1 - 1940 feet North and 2045 feet West, Spring No. 2 -2295 feet North and 1190 feet West, both from SE Corner, Section 34

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ----- of one cubic foot per second per acre,
