CERTIFICATE OF WATER RIGHT

This Is to Certify, That UNITED STATES FISH AND WILDLIFE SERVICE

of 500 NE Multnomah Street, Portland, State of Oregon 97232, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Well No. 0-2

a tributary of Columbia River for the purpose of irrigation of 188.4 acres

under Permit No. G-6032 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 13, 1974

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.36 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the Lot 3 (SW $\frac{1}{4}$ NW $\frac{1}{4}$), Section 16, T. 5 N., R. 26 E., W.M.; 130 feet North and 4060 feet West from E $\frac{1}{2}$ Corner, Section 16

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the completed well shall not exceed 60 feet nor appropriate water from an aquifer below the depth of the alluvial gravels

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

 37.4 acres Lot 3 (SW $\frac{1}{4}$ NW $\frac{1}{4}$)
 41.5 acres Lot 4 (SE $\frac{1}{4}$ NW $\frac{1}{4}$)
 29.7 acres Lot 9 (NE $\frac{1}{4}$ SW $\frac{1}{4}$)
 29.1 acres Lot 10 (NW $\frac{1}{4}$ SW $\frac{1}{4}$)
 3.4 acres Lot 8 (NW $\frac{1}{4}$ SE $\frac{1}{4}$)
