under Permit No. G-5159 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 1, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.40 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the Lot 3 (SE $\frac{1}{4}$ NW $\frac{1}{4}$), Section 21, T. 5 N., R. 26 E., W. M.; 1340 feet South and 3950 feet West from NE Corner, Section 21

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the completed well shall not exceed the depth of the alluvial gravels nor appropriate water from an aquifer below that depth

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
