CERTIFICATE OF WATER RIGHT

This Is to Certify, That

of Route 1, Box 260, Sheridan , State of Oregon 97378 , has a right to the use of the waters of a spring and an unnamed stream for Tract 1, a spring for Tract 2 and an unnamed stream for Tract 3

a tributary of South Yamhill River for the purpose of domestic use of one family including the irrigation of 0.2 acre lawn and garden (Tract 1), stock (Tract 2), and irrigation (Tract 3)

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Yamhill County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 18, at page 262; that the priority of the right thereby confirmed dates from 1901

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.141 cubic foot per second being 0.01 cubic foot per second for domestic, 0.005 cubic foot per second for stock and 0.126 cubic foot per second for irrigation.

The point of diversion is located in the NE 1_4 NE 1_4 , NW 1_4 NE 1_4 , both as projected within N. Doane DLC 55, Section 23, NW 1_4 SE 1_4 , as projected within N. Doane DLC 55, Section 14, Township 6 South, Range 7 West, Willamette Meridian; Spring - 30 feet south and 880 feet west; unnamed stream - 660 feet south and 1470 feet west; * A description of the place of use under the right, and to which such right is appurtenant, is as follows:
