CERTIFICATE OF WATER RIGHT

This Is to Certify, That WALLACE B. HEIDER

of 1330 W. Main Street, Sheridan, State of Oregon 97378, has
a right to the use of the waters of South Yamhill River

a tributary of Yamhill River
irrigation of 32.1 acres

for the purpose of

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Yamhill County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 18, at page 262; that the priority of the right thereby confirmed dates from 1907

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.40 cubic foot per second.

The point of diversion is located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within J. Graves DLC 42, Section 34, Township 5 South, Range 6 West, Willamette Meridian, being 1230 feet north and 1210 feet east from the W $\frac{1}{4}$ corner Section 34.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

11.5 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within J. Graves DLC 42
2.3 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within W. Chapman DLC 41
0.2 acre Lot 1 (SW $\frac{1}{4}$ NW $\frac{1}{4}$)
0.5 acre SE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within J. Graves DLC 42
2.9 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within W. Chapman DLC 41
5.2 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within W. Chapman DLC 41
6.9 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within W. Chapman DLC 41
0.1 acre NW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within J. Graves DLC 42
2.5 acres Lot 1 (NW $\frac{1}{4}$ SW $\frac{1}{4}$)


