a tributary of Berry Creek for the purpose of domestic use of one family including the irrigation of 0.5 acre lawn and garden (Tract 1), stock (Tract 2), and stock drinking directly from the sources and is limited not to exceed 160 head (Tracts 3 and 4)

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Yamhill County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 18, at page 262; that the priority of the right thereby confirmed dates from 1865

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.015 cubic foot per second being 0.01 cubic foot per second for domestic and 0.005 cubic foot per second for stock; and shall be further limited to the provisions of Finding No. 77 of said Decree.

The point of diversion is located in the NW_4^1 SE $_4^1$, Section 35, Township 3 South, Range 5 West, Willamette Meridian, being 180 feet north and 1440 feet west from the SE corner of the NE_4^1 Se $_4^1$, Section 35.

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually reneficially used for said purposes, and shall not exceed 0.015 cubic foot per second being 0.01 cubic foot per second for domestic and 0.005 cubic foot per second for stock; and shall be further limited to the provisions of Finding No. 77 of said Decree.
