CERTIFICATE OF WATER RIGHT

This Is to Certify, That

FRANK H. AND VIOLA M. GOULD

of Route 1, Box 1718, Bandon , State of Oregon 97411 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Crooked Creek

a tributary of $\mbox{Pacific Ocean}$ for the purpose of irrigation of 5.7 acres, temperature control, and cranberry harvest

under Permit No. 35868 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 14, 1971

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.42 cubic foot per second, being 0.14 c.f.s. for irrigation, 0.42 c.f.s. for temperature control, and 0.28 c.f.s. for cranberry harvest

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 SE4, Section 7, T. 29 S., R. 14 W., W.M.; 480 feet North and 1250 feet West from SE Corner, Section 7

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year, for cranberries; if for the irrigation of any other crop, this appropriation shall be limited to one-eightieth of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.7 acres NE4 NW4 Section 18 T. 29 S., R. 14 W., W.M.

This certificate correctly describes the location of the land and supersedes certificate recorded at page 44362, Volume 36, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
