CERTIFICATE OF WATER RIGHT

This Is to Certify, That BRADFORD C. TROWBRIDGE

of John Day, State of Oregon 97845, has
a right to the use of the waters of
John Day River

a tributary of Columbia River for the purpose of
irrigation of 177.3 acres and stock use for Tract 1 and irrigation of 2.6 acres
for Tract 2,

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Grant County, and the said decree entered of record at Salem, in the Order Record of
the WATER RESOURCES DIRECTOR, in Volume 15, at page 461; that the priority of the
right thereby confirmed dates from 1863 for Tract 1; 1875 for Tract 2;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed 1/40 cubic foot per
second per acre irrigated from April 1 to September 30; further limited to one
acre-foot per acre per calendar month to July 1 and 3/4 acre-foot per acre
thereafter; total five acre-feet per acre for season, measured at point of diver-
sion.

The point of diversion is located in the Tract 1 - NE $\frac{1}{2}$ NE $\frac{1}{4}$, Section 25, T. 13 S., R. 31
E., W.M.; Tract 2 - SW $\frac{1}{2}$ SW $\frac{1}{4}$, Section 20, T. 13 S., R. 32 E., W.M.


This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 42919, Volume 34, State Record of Water Right Certificates, NOT modified by the provisions of orders of the Water Resources Director entered on August 7, 1980, approving transfer applications Nos. 4532, 4533, 4534, 4535, 4536 and 4537 and NOT canceled by the provisions of an order of the Water Resources Director entered on August 7, 1980.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
