## CERTIFICATE OF WATER RIGHT

This Is to Certify, That HARRY PON

of PO Box 1191, Burns , State of Oregon 97720 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Wells No. 5 and 14

a tributary of East Branch Foley Slough (Silvies River) supplemental irrigation of 333.3 acres

for the purpose of

under Permit No. G-1808 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 3, 1961

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.16 cubic feet per second; being 3.13 c.f.s. from Well No. 5 and 1.03 c.f.s. from Well No. 14,

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 28; SW $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 33, T. 22 S., R. 31 E., W.M.; No. 5 - 100 feet South and 620 feet West from NE Corner, SE $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 28; No. 14 - 530 feet North and 1200 feet East from SW Corner, Section 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
