CERTIFICATE OF WATER RIGHT

This Is to Certify, That LEON BROWN

of 950 Rogue Wood Drive, Central Point, State of Oregon 97502, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean for the purpose of irrigation of 18.0 acres

under Permit No. 9600 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon: that the priority of the right hereby confirmed dates from March 29, 1930

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.19 cubic foot per second, if available at the original point of diversion, SW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 31, T. 35 S., R. 1 W., W.M., 70 feet North and 1400 feet West from E $\frac{1}{2}$ Corner, Section 31,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 31, T. 35 S., R. 1 W., W.M.; 350 feet South and 10 feet West from NE Corner, SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

15.0 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$
3.0 acres SE $\frac{1}{4}$ NE $\frac{1}{4}$
Section 31
T. 35 S., R. 1 W., W.M.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered on December 8, 1976, and together with certificate of water right recorded on page 44304, Volume 36, State Record of Water Right Certificates, supersedes certificate of water right recorded at page 43993, Volume 36, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
