under Permit No. 32187 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 2, 1966

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforcsaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.19 cubic foot per second, if available at the original point of diversion; SW_4 SE_2 , Section 21, T. 11 S., R. 1 W., W.M.; 330 feet North and 1350 feet West from SE Corner, Section 21

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW_4 SE $_4$, Section 21, T. 11 S., R. 1 W., W.M.; 20 feet North and 1580 feet West from SE Corner, Section 21

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered on May 28, 1974, and together with certificate of water right recorded at page 43605, Volume 35, State Record of Water Right Certificates, supersedes certificate of water right recorded at page 37957, Volume 30, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
