CERTIFICATE OF WATER RIGHT

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Malheur County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at page 258; that the priority of the right thereby confirmed dates from 1871 for 150 acres; 1873 for 130.5 acres,

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a rate of flow of 7.01 second feet from February 15 to May 1 and 3.50 second feet from May 1 to September 1 of each year, or the equivalent in case of rotation; the total quantity diverted during each irrigation season not to exceed 841.5 acre-feet.

The point of diversion is located in the NE $\frac{1}{2}$ NE $\frac{1}{2}$, Section 9, T. 16 S., R. 43 E., W.M.; Hammack & Maag Ditches - 1304 feet South and 139 feet West from NE Corner, Section 9.
