under Permit No. 34068 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 21, 1968
that the amount of water to which such right is entitled and hereby confirmed for the purposes

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.48 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$, Section 13, SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 14, T. 4 S., R. 39 E., W.M.; 710 feet North and 400 feet West from SE Corner, Section 13, 400 feet North and 1140 feet East from S $\frac{1}{4}$ Corner, Section 14

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right

is appurtenant, is as follows: 11.1 acres NW4 SE4

18.3 acres SW4 SE4

Section 14 T. 4 S., R. 39 E., W.M.

This certificate is issued to confirm an additional point of diversion approved by an order of the Water Resources Director entered on April 20, 1977 and together with certificate of water right recorded at page 45111, Volume 37, State Record of Water Right Certificates, supersedes certificate of water right recorded at page 40960, Volume 33, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to DRS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
