CERTIFICATE OF WATER RIGHT

This Is to Certify, That EUGENE M. VANDEHEY

of Route 1, Box 355, Forest Grove, State of Oregon 97116, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of West Fork of Dairy Creek

a tributary of Dairy Creek for the purpose of irrigation of 30.0 acres

under Permit No. 13388 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 19, 1938

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.375 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within John Lousignout DLC 52, Section 12, T. 1 N., R. 4 W., W.M.; 440 feet South and 450 feet East from W $\frac{1}{4}$ Corner, Section 12

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in place of use approved by an order of the Water Resources Director entered on April 15, 1974 and together with certificate of water right recorded at page 39604, Volume 31, State Record of Water Right Certificates, supersedes certificate of water right recorded at page 14207, Volume 12, State Record of Water Right Certificates.


The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
