## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

LEE VERN BOTHWELL

of Gateway Route, Madras , State of Oregon 97741 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of three excavated pits

a tributary of Trout Creek for the purpose of irrigation of 8.25 acres and supplemental irrigation of 69.75 acres

under Permit No. G-1456 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 22, 1959

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.45 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NE4 SW4, NW4 SW4, and SW4 SW4, Section 9, T. 9 S., R. 15 E., W.M.; Pit No. 1 - 1 chain South and 14 chains West; Pit No. 2 - 17 chains South and 24.5 chains West; Pit No. 3 - 26 chains South and 33.5 chains West, all from Center, Section 9

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
