## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

HENRY A. GONSETH

of 39151 River Drive, Lebanon , State of Oregon 97355 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Santiam River

a tributary of Santiam River irrigation of 4.8 acres

for the purpose of

under Permit No. 18688 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon: that the priority of the right hereby confirmed dates from February 17, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second if available at the original point of diversion; NE4 NW4, as projected within Ambler DLC 57, Section 29, T. 12 S., R. 1 W., W.M.; 10 feet South and 10 feet West from N4 Corner, Section 29,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 SW4, as projected within Ambler DLC 57, Section 20, T. 12 S., R. 1 W., W.M.; 100 feet North and 3000 feet West from SE Corner, Section 20.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right

is appurtenant, is as follows: 0.4 acre SE4 SW4

Section 20 4.4 acres NE½ NW¼ Section 29

both as projected within Ambler DLC 57 T. 12 S., R. 1 W., W.M.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered January 6, 1978, and together with certificate of water right recorded at page 45171, Volume 37, State Record of Water Right Certificates, supersedes certificate recorded at page 24523, Volume 17, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
