## CERTIFICATE OF WATER RIGHT

of Milton-Freewater , State of Oregon 97862 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Swartz Spring Creek

a tributary of Pine Creek irrigation of 370.0 acres

for the purpose of

under Permit No. 519 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 26, 1910

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.625 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

The certificate recorded at page 45580, Volume 38, State Record of Water Right Certificates incorrectly referred to transfer application Nos. 3862 and 3792 as modifying portions of the prior water right confirming certificate 2435. The correct modifying transfer applications were W-56, entered June 23, 1952 and 2803, entered March 17, 1978.

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 45580, Volume 38, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered on December 13, 1979.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described., and is subject to the existing minimum flow policies established by the Water Policy Review Board.
