CERTIFICATE OF WATER RIGHT

This Is to Certify, That HARVEY L. YOUNG

of Route 1, Box 43A, Lowden, State of Washington 99342, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Schwartz Spring Branch

a tributary of Pine Creek for the purpose of irrigation of 33.8 acres

under Permit No. 32059 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 10, 1966

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.47 cubic foot per second, if available at the original point of diversion, NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 16, T. 6 N., R. 34 E., W.M., 1360 feet South and 4070 feet East from W $\frac{1}{2}$ Corner, Section 16, subject to the provisions of Special Order Volume *

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 16, T. 6 N., R. 34 E., W.M.; 1360 feet North and 1360 feet East from SW Corner, Section 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-sixtieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

20.6 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$
13.2 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$
Section 16
T. 6 N., R. 34 E., W.M.


This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered on July 13, 1978, and supercedes certificate of water right recorded at page 38870, Volume 30, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
