of Route 3, Box 59A, The Dalles , State of Oregon 97058 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Fifteen Mile Creek

a tributary of Columbia River irrigation of 55.7 acres

for the purpose of

under Permit No. 6421 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 23, 1924

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.70 cubic foot per second, if available at the original point of diversion: NW_4 , NW_4 , Section 9, T. 1 N., R. 15 E., W.M., South 40 degrees East, 1248 feet from NW Corner, Section 9,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $_3$ SE $_4$, NE $_4$ NW $_5$, Section 4, T. 1 N., R. 15 E., W.M.; Diversion Point No. 1 - 80 feet North and 2240 feet West from SE Corner, Section 4; Diversion Point No. 2 - 930 feet South and 840 feet West from N $_4$ Corner, Section 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to One-eightiethof one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described., and is subject to the existing minimum flow policies established by the Water Policy Review Board.
