that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 11 gallons per minute, being 1 g.p.m. from Spring No. 1, 5 g.p.m. from Spring No. 2, 1 g.p.m. from Spring No. 3 and 1 g.p.m. from Spring No. 4 for stock and 2 g.p.m. from Spring No. 3 and 1 g.p.m. from Spring No. 4 for domestic

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the No. 1 - SE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 26, No. 2 - SE $\frac{1}{4}$ SW $\frac{1}{4}$; No. 3 and No. 4 - NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 25, T. 2 N., R. 12 E., W.M.; No. 1 - 100 feet North and 980 feet West from the S $\frac{1}{4}$ Corner, Section 26; No. 2 - 390 feet North and 1470 feet East from the SW Corner, Section 25; No. 3 - 730 feet South and 230 feet East; No. 4 - 880 feet South and 280 feet East; both from NW Corner*

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ----- of one cubic foot per second per acre,
