This Is to Certify, That

SILVER LAKE IRRIGATION DISTRICT C/O LAWRENCE IVERSON

of Silver Lake , State of Oregon 97638 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Silver Creek, East Thompson Valley Reservoir and Diversion Dam Reservoir constructed under Permit R-680 a tributary of Silver Lake (dry) for the purpose of irrigation and supplemental irrigation of 2,668.1 acres

under Permit No. 11656 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 11, 1915

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 47 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 SE 1/4, Section 24, T30S, R13E, WM; Creek-2,800 feet South and 500 feet West from NE Corner, Section 24, SE 1/4SW 1/4, Section 17, T30S, R14E, WM; E.T.V. Reservoir-600 feet North and 1,700 feet East from SW Corner, Section 17, Lot 1 (NE 1/4 NE 1/4,) Section 5, T29S, *

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second $per\ acre,$ or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from East Thompson Valley Reservoir and Diversion Dam Reservoir constructed under Permit R-680

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

* R14E, WM; D.D. Reservoir-100 feet South and 1,300 feet West from NE Corner, Section 5.
