CERTIFICATE OF WATER RIGHT

This Is to Certify, ThatSILVER LAKE IRRIGATION DISTRICT
C/O LAWRENCE IVERSON

of Silver Lake, State of Oregon 97638, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of East Thompson Valley Reservoir enlarged under Permit R-4461

a tributary of Silver Creek for the purpose of supplemental irrigation of 2,668.1 acres

under Permit No. 29955 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 24, 1964

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2,040 acre-feet stored water only

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 SW 1/4, Section 17, T30S, R14E, WM, 600 feet North and 1,700 feet East from Southwest Corner Section 17

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~-----of one cubic foot per second per acre~~, a diversion of three acre-feet per acre or its equivalent for each acre irrigated during the irrigation season of each year.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.


