a tributary of Santiam River irrigation of 56.7 acres

under Permit No. G-7005 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 1, 1976

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.71 cubic foot per second, being 0.20 c.f.s. from Well No. 1, 0.23 c.f.s. from Well No. 2, and 0.28 c.f.s. from Well No. 7

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NW \pm NW \pm NW \pm SW \pm , Section 4, T. 10 S., R. 3 W., W.M.; Well No. 1 - 1460 feet South and 800 feet East; Well No. 2 - 20 feet South and 800 feet East; Well No. 7 - 3260 feet South and 190 feet East, all from NW Corner, Section 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

 <u>Well No. 2</u> 10.3 acres Lot 4 (SW¼ SW¼) Section 33 T. 9 S., R. 3 W., W.M.

Well No. 7 11.1 acres SW¼ NW¼ 11.5 acres NW¼ SW¼ Section 4 T. 10 S., R. 3 W., W.M.

8.2 acres NW¼ NW¼ Section 4 T. 10 S., R. 3 W., W.M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
