CERTIFICATE OF WATER RIGHT

This Is to Certify, That LOUREE CUNNINGHAM

of 4425 Fourth Street, Riverside, State of California 92501, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Well No. 4

a tributary of South Santiam River for the purpose of supplemental irrigation of 114.0 acres

under Permit No. G-6768 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 12, 1976

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.35 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 23, T. 11 S., R. 2 W., W.M.; 1080 feet North and 1180 feet East from SE Corner, Wassom DLC 49

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


