CERTIFICATE OF WATER RIGHT

This Is to Certify, That STIAN E. SMITH

of South Coos River Route, Box 308, Coos Bay, State of Oregon 97420, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Fork Coos River and a spring

a tributary of Coos River for the purpose of irrigation of 22.5 acres, stock, dairy use, and domestic use for three families

under Permit No. 40665 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 26, 1976

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.305 cubic foot per second, being 0.28 cfs for irrigation, 0.005 cfs for stock, and 0.005 cfs for dairy use from South Fork Coos River; and 0.01 cfs for domestic and 0.005 cfs for dairy use from the spring

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the Lot 7 (NW $\frac{1}{4}$ SW $\frac{1}{4}$) and Lot 6 (SW $\frac{1}{4}$ NW $\frac{1}{4}$), Section 36, T25S, R12W, WM; Spring - 1,210 feet South and 500 feet East; South Fork Coos River - 590 feet North and 740 feet East, 220 feet North and 1,140 feet East from W $\frac{1}{2}$ Corner, Section 36

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

domestic, stock, dairy, and 16.2 acres Lot 6 (SW $\frac{1}{4}$ NW $\frac{1}{4}$)
domestic, stock, and 6.3 acres Lot 7 (NW $\frac{1}{4}$ SW $\frac{1}{4}$)
Section 36
Township 25 South, Range 12 West, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
