## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

CURTIS TRENT

of Route 2, Box 672, Roseburg , State of Oregon 97470 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of North Umpqua River

a tributary of Umpqua River irrigation of 5.82 acres

for the purpose of

under Permit No. 28229 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 31, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.075 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 SE 1/4 as projected within McKinney DLC 47, Section 22, T26S, R6W, WM, 60 feet North and 400 feet West from the SE Corner of Section 22.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to use of water is limited to the period when the flow of the North Umpqua River is more than 525 cfs at its mouth,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 1.4 acres SE 1/4 SE 1/4 as projected within McKinney DLC 47 Section 22
- 1.6 acres SW 1/4 SW 1/4 as projected within McKinney DLC 47 Section 23
- 1.6 acres NW 1/4 NW 1/4 as projected within McKinney DLC 47 Section 26  $\,$
- 1.22 acres NE 1/4 NE 1/4 as projected within McKinney DLC 47 Section 27 Township 26 South, Range 6 West, WM

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 32648, Volume 24, State Record of Water Right Certificates, NOT modified by the provisions of orders of the Water Resources Director entered on December 29, 1980, approving Transfer Applications T-4617, T-4618, T-4620, T-4621, T-4629 and T-4637.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described., and is subject to the existing minimum flow policies established by the Water Policy Review Board.
