CERTIFICATE OF WATER RIGHT

This Is to Certify, That

HENRY L. and ENGINA J. NATENSTEDT

of Azalea , State of Oregon 97410 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Meadow Creek and Lewis Reservoir 1, constructed under Permit R-2198

a tributary of Cow Creek irrigation of 13.4 acres

for the purpose of

under Permit No. 25835 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 10, 1958

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.19 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 NE 1/4, Section 31, T31S, R3W, WM, 470 feet South and 260 feet East from the N 1/4 Corner of Section 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone—seventieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-2198, provided further that the right to the use of water is limited to the period when the flow of water in Cow Creek is 11.0 cfs or more at its mouth,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.8 acre NE 1/4 SE 1/4

3.2 acres NW 1/4 SE 1/4

3.6 acres SW 1/4 SE 1/4

5.8 acres SE 1/4 SE 1/4

Township 31 South, Range 3 West, WM

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 31346, Volume 23, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on November 20, 1980, approving Transfer Application 4619.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
