CERTIFICATE OF WATER RIGHT

of PO Box 157, Eagle Point , State of Oregon 97524 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Hog Creek

a tributary of Rogue River for the purpose of irrigation of 20.0 acres and supplemental irrigation of 37.8 acres

under Permit No. 31577 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 18, 1966

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.72 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 SE 1/4, Section 22, NW 1/4 NE 1/4, NE 1/4 NW 1/4, NW 1/4 SW 1/4, Section 21, T35S, R1W, WM; Diversion Point 11 - 1,210 feet South and 690 feet East from Center, Section 22; Diversion Point 12 - 300 feet South and 1,160 feet East; Diversion Point 13 - 1,100 feet South and 70 feet West, both from N 1/4 Corner, Section 21, Diversion Point 14 *

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
