CERTIFICATE OF WATER RIGHT

EAGLE POINT IRRIGATION DISTRICT

of PO Box 157, Eagle Point , State of Oregon 97524 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Fork Reese Creek , Reese Creek and North Fork Reese Creek

a tributary of Rogue River for the purpose of irrigation of 12.9 acres and supplemental irrigation of 130.4 acres

under Permit No. 30290 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 4, 1965

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.79 cubic feet per second measured at point of diversion, being 0.16 cfs from South Fork Reese Creek, 0.95 cfs from Reese Creek and 0.68 cfs from North Fork Reese Creek,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the North Fork Reese Creek: NE 1/4 SE 1/4, Section 1, SW 1/4 NW 1/4 Section 12, T35S, R1W, WM; Diversion Point 5 - 1,430 feet North and 900 feet West from SE Corner, Section 1; Diversion Point 6 - 1,220 feet North and 520 feet East from W 1/4 Corner, Section 12. South Fork Reese Creek: NW 1/4 SE 1/4, Section 32, T34E, R1E, WM; Diversion Point 3 *

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
