## CERTIFICATE OF WATER RIGHT

*This Is to Certify, That* CLAIR HULL

of 34129 Tennessee Road, Lebanon, State of Oregon 97355, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Santiam River

a tributary of Santiam River for the purpose of supplemental irrigation of 142.0 acres

under Permit No. 41427 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 18, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.78 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected within Abbott DLC 56, Section 25, T. 11 S., R. 2 W., W.M.; 680 feet South and 700 feet East from NW Corner, Section 25

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


