CERTIFICATE OF WATER RIGHT

This Is to Certify, That HOWARD A. SCHELSKE

of Route 2, Box 277, Jefferson , State of Oregon 97352 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Wells No. 3, 4, and 5

a tributary of Santiam River irrigation of 13.4 acres

for the purpose of

under Permit No. G-7161 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 8, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.17 cubic foot per second, being 0.01 c.f.s. from Well No. 3, 0.12 c.f.s. from Well No. 4 and 0.04 c.f.s. from Well No. 5

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE¼ SE¼, as projected within Holt DLC 62, Section 14, Lot 1 (NE¼ NE¾), Section 23, T. 10 S., R. 3 W., W.M.; Well No. 3 - 500 feet North and 230 feet West, Well No. 4 - 160 feet North and 320 feet West, Well No. 5 - 50 feet South and 200 feet West, all from SE Corner, Section 14.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
