a tributary of Applegate River irrigation of 0.8 acre

for the purpose of

under Permit No. 27109 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 13, 1960

that the amoun. of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW_4 NE $_4$, Section 28, T38S, R4W, WM; 740 feet South and 1470 feet West from the NE corner of Section 28.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to the use of water is limited to the period when the flow of the Rogue River is more than 735 cfs at its mouth,

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.7 acre NE¾ NE¼ 0.1 acre NW¾ NE¼ Section 28 Township 38 South, Range 4 West, WM

This certificate is issued to confirm a change in place of use and point of diversion approved by an order of the Water Resources Director entered July 1, 1976 and together with certificate of water right recorded at page 43758, Volume 35, State Record of Water Right Certificates, supersedes certificate of water right recorded at page 33158, Volume 25, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
