CERTIFICATE OF WATER RIGHT

This Is to Certify, That

RICK CANTRELL

of Route 1, Box 115, Dufur , State of Oregon 97021 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Ramsey Creek and Fifteenmile Creek

a tributary of Columbia River for the purpose of irrigation of 104.5 acres from Ramsey Creek and 28.5 acres from Fifteenmile Creek

under Permit No. 40564 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 27, 1976

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.67 cubic feet per second, being 1.31 c.f.s. from Ramsey Creek and 0.35 c.f.s. from Fifteenmile Creek

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 NW4, Section 6, T. 2 S., R. 13 E., W.M.; Ramsey Creek - 140 feet South and 350 feet East from NW Corner, Section 6, SW4 SE4, Section 31, T. 1 S., R. 13 E., W.M., Fifteenmile Creek - 20 feet North and 3540 feet East from SW Corner, Section 31

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
