## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** I. N. YOUNG

of Richland, State of Oregon 97870, has  
a right to the use of the waters of  
Eagle Creek

a tributary of Powder River for the purpose of  
irrigation of 97.7 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Baker County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at page 291; that the priority of the right thereby confirmed dates from 1874

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one-fortieth of one cubic foot per second per acre,

The point of diversion is located in the SE $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 10, T9S, R45E, WM; Kay Young Ditch - 1,700 feet South and 2,450 feet East from NW Corner, Section 10; NW $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 3, T9S, R45E, WM; Moody Ditch - 2,130 feet North and 650 feet East from SW Corner, Section 3.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

2.5 acres NW $\frac{1}{4}$  SW $\frac{1}{4}$   
16.0 acres NW $\frac{1}{4}$  SW $\frac{1}{4}$   
24.0 acres SW $\frac{1}{4}$  SW $\frac{1}{4}$   
Section 14

24.4 acres NE $\frac{1}{4}$  SE $\frac{1}{4}$   
30.8 acres SE $\frac{1}{4}$  SE $\frac{1}{4}$   
Section 15


This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 4773, Volume 5, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on December 29, 1980, approving Transfer Application 4576.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
