## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** LESLIE & MARJORIE WALKER

of P.O. Box 119, Canyonville, State of Oregon 97417, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Canyon Creek

a tributary of South Umpqua River for the purpose of irrigation of 0.07 acre

under Permit No. 17456 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 2, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.002 cubic foot per second, if available at the original point of diversion SE $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 27, as projected within Clark DLC 51, T30S, R5W, WM; 530 feet North and 2200 feet East From the W $\frac{1}{2}$  Corner, Section 27

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SE $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 27, as projected within Clark DLC 51, T30S, R5W, WM; 25 feet South and 15 feet East from NW Corner, Lot 4 Canyon Creek Estates.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


This certificate is issued to correctly describe the acreage irrigated and
