## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

DAVID S. BLAIR

of Route 1, Box 100, Rogue River , State of Oregon 97537 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Mays Creek and reservoir constructed under Permit R-872

a tributary of Evans Creek for the purpose of irrigation of 17.0 acres and supplemental irrigation of 22.5 acres

under Permit No. 17593 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 6. 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.495 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 32, T34S, R3W, WM; 35 feet North and 1,675 feet East from W $\frac{1}{4}$  Corner, Section 32.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4½ acre-feet per acre for each acre irrigated during the irrigation season from April 2 to October 31 of each year from direct flow and storage from reservoir constructed under Permit R-872,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
