## CERTIFICATE OF WATER RIGHT

This Is to Certify, That A. S. KLEINHAMMER

of Buncom, State of Oregon, has  
a right to the use of the waters of  
Little Applegate River

a tributary of Applegate River for the purpose of  
irrigation of 100.2 acres, domestic, and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at page 1; that the priority of the right thereby confirmed dates from September 1, 1857 for 1.96 cfs for irrigation of 78.2 acres; 1898 for 0.55 cfs for irrigation of 22 acres, domestic and stock use; that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.51 cubic feet per second.

The point of diversion is located in the NE $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 29, T39S, R2W, WM.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:


The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use hereinafter described.
