CERTIFICATE OF WATER RIGHT

This Is to Certify, That OLIVE M. McRAE

of Route 1, Box 1147, Grants Pass, State of Oregon 97526, has
a right to the use of the waters of
Jump-Off-Joe Creek

a tributary of Rogue River for the purpose of
irrigation of 23.0 acres, domestic and stock use in Tract 1, and irrigation of
40.0 acres, domestic and stock use in Tract 2.

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
JOSEPHINE County, and the said decree entered of record at Salem, in the Order Record of
the WATER RESOURCES DIRECTOR, in Volume 4, at page 1; that the priority of the right
thereby confirmed dates from

1872 for Tract 1 and 1871 for Tract 2

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed

0.33 cubic foot per second for Tract 1 and 0.58 cubic foot per second for Tract
2.

The point of diversion is located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 4, T35S, R5W, WM; 1,710 feet
South and 280 feet West from the N $\frac{1}{4}$ Corner, Section 4.

A description of the place of use under the right, and to which such right is appurtenant, is as
follows:

This certificate describes that portion of the water right confirmed by the prior
certificate recorded at page 39368, Volume 31, State Record of Water Right
Certificates, NOT modified by the provisions of an order of the Water Resources
Director entered on January 19, 1981, approving Transfer Application 4623.

The issuance of this superseding certificate does not confirm the status of the
water right in reference to ORS 540.610.

And said right shall be subject to all other conditions and limitations contained in said decree.
The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein
described.
