CERTIFICATE OF WATER RIGHT

This Is to Certify, That GEORGE S. & DORIS M. SEBITS

of 41782 Fish Hatchery Drive, Scio, State of Oregon 97374, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Roaring River

a tributary of Crabtree Creek for the purpose of irrigation of 21.5 acres

under Permit No 13506 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 17, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.27 cubic foot per second, if available at the original point of diversion; NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 8, T11S, R1E, WM; 1920 feet North and 1100 feet East from SW Corner, Section 8.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 7, T11S, R1E, WM; 2030 feet North and 2740 feet West from SE Corner, Section 7.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

16.9 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
4.2 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$
0.4 acre SW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 7


This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered August 25, 1971 and supersedes certificate of water right recorded at page 31672, Volume 23, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
